#### Item 1. Description of Registrant's Securities to be Registered.

The Registrant and the Co-Registrants on this registration statement (the "Co-Registrants") register hereunder €300,000,000 aggregate principal amount of 3.250% Notes Due 2019 (the "Notes") issued by the Registrant's subsidiary, Celanese US Holdings LLC, a Co-Registrant on this registration statement.
