- The Phantom Stock represents Restricted Stock Units and DERs accrued on such Restricted Stock Units deferred under the Company's 2008 Deferred Compensation Plan. The shares of Phantom Stock become payable in cash or shares of Series A Common Stock, as provided in the Company's 2008 Deferred Compensation Plan, following the termination of the reporting person's service as director of the Company.
