The restricted stock units will vest, subject to continued employment, with respect to 30% of the restricted stock units on October 1, 2012, with respect to 30% of the restricted stock units on October 1, 2013, and with respect to 40% of the restricted stock units on October 1, 2014.
- (2) Represents equivalent shares of Series A Common Stock held by the reporting person under the Celanese Americas Retirement Savings Plan as of September 30, 2011.
- (3) Granted pursuant to the Company's 2009 Global Incentive Plan. The options will vest, subject to continued employment, with respect to 25% of the options on each of October 1, 2012, October 1, 2013, October 1, 2014 and October 1, 2015.
