Explanation of Responses:

- (1) Restricted stock units granted pursuant to the Company's 2009 Global Incentive Plan. Each restricted stock unit represents a contingent right to receive one share of Series A Common Stock. The restricted stock units will vest, subject to continued employment, with respect to 30% of the restricted stock units on October 1, 2012, with respect to 30% of the restricted stock units on October 1, 2013, and with respect to 40% of the restricted stock units on October 1, 2014.
- (2) Granted pursuant to the Company's 2009 Global Incentive Plan. The options will vest, subject to continued employment, with respect to 25% of the options on each of October 1, 2012, October 1, 2013, October 1, 2014 and October 1, 2015.
