The options vest with respect to 15% of the Option Shares on January 20, 2005, and subject to continued employment, with respect to 20% on each of December 31, 2005, December 31, 2006, December 31, 2007 and December 31, 2008, and with respect to the remaining 5% on March 31, 2009.
- (2) Granted pursuant to the Company's 2004 Stock Incentive Plan. The options vest with respect to 15% of the Option Shares on January 20, 2005, and subject to continued employment, the remaining shares vest on January 20, 2012, but which vesting may accelerate based on the achievement of certain performance criteria.

This Amended Form 4 corrects the Title of Derivative Securities, the Transaction Code, and the expiration date disclosed in the originally filed Form 4, and provides further details on the vesting schedule of the option grant.
